in securities to be used as collateral for the repayment of principal amounts in the event of
default of any of FJC's agency loans receivable. This agreement remains in effect until July
1, 2017 and is renewable by mutual consent. As of March 31, 2016, the fair value of the
collateral held as security under the pledge agreement was approximately \$30,239,000. (ii) In
a separate capacity, Mark Cohen (as an Attorney), performs professional services for which he
is compensated for entities of which Lorin Silverman has an ownership interest.
