FJC'S INAUGURAL COLLECTIVE GIVING CAMPAIGN:

Goal is to Amplify Donor Giving Across 6 Pre-Selected Organizations with up to **\$150K** from our Special Initiatives Fund

Dear FJC Donors,

During these unprecedented times, it can be difficult to know how to make a difference. The global scale of the coronavirus pandemic can feel overwhelming. Beyond social distancing to flatten the curve, what can each of us do to mitigate the effects of the pandemic? What obligation do we have as philanthropists to direct resources to people and communities that are most vulnerable?

As CEO of FJC, I have been reflecting a lot on our Foundation's collective resources. During normal times, I tend to think of a platform like FJC as one that provides efficiency to its many hundreds of Donor Advised Fund account holders, who are typically seeking a solution to their philanthropy that combines the flexibility of a family foundation with a low-cost and hassle-free solution. However, during times of crisis like these, I have been considering the potential of FJC to aggregate, combine, and leverage. If all of us were to work together, could we deliver an impact more than the sum of our parts?

FJC staff have assembled 6 outstanding organizations and initiatives that:

- Serve vulnerable populations that are being especially affected by the COVID-19 pandemic and its economic effects; and / or
- Provide a range of responses in NYC (the pandemic's US epicenter); and / or

- Support global research and development of vaccines and treatments to fight the novel coronavirus; and
- Have strong reputations for putting philanthropic dollars to work.

We invite you, our donors, to join us in supporting this campaign. FJC will match your giving with contributions from our Special Initiatives Fund up to \$25,000 per organization. Here's how it works:

Donors make grant recommendations for one or more of our six selected organizations through the <u>FJC donor portal</u>.

At the end of the giving period, FJC will tally the total number of dollars recommended by FJC donors to the 6 organizations.

FJC will match the aggregate commitments of its donors up to \$25,000 for each of the six organizations.

To be considered for the FJC match, all recommendations must be received in the donor portal by Friday, May 29, 2020.

As a magnifying glass focuses beams of sunlight, concentrating our resources will intensify their power. We also hope to learn about what matters to you by your feedback and participation. We may find that these lenses resonate with you beyond the context of the current crisis, and that we can form communities of interest around them, via webinars, conference calls and even (dare we imagine this someday?) in person meetings.

FOOD SECURITY LENS

The National Domestic Workers Alliance's Coronavirus Care Fund (CCF) provides emergency assistance for qualifying home care workers, nannies and house cleaners who are experiencing financial hardship due to the coronavirus pandemic. Many domestic workers are on the frontlines of the outbreak and are unable to social distance, caring for those most vulnerable to the coronavirus like seniors and people with chronic illnesses. Those who do stay home, face another challenge; as low-wage workers without a safety net or paid time off, they are hit the hardest by any national crisis, including this pandemic.
